- DISTRIBUTORS' COSTS AND MARGINS ON FURNITURE, DOMESTIC ELECTRICAL APPLIANCES AND FOOTWEAR.
- Direction under section 5 (4) extending the period within which the National Board for Prices and Incomes must publish their report.

Whereas the First Secretary of State, the President of the Board of Trade and the Minister of Technology, in pursuance of their powers under section 2 (1) of the Prices and Incomes Act 1966, referred the above-mentioned question to the National Board for Prices and Incomes for examination and have published the text of the reference in the Gazette on 17th August 1967.
