TERRITORIAL AND AUXILIARY ASSOCIATION FOR THE ISLE OF MAN

Order by the Defence Council

The Defence Council in exercise of the powers conferred upon them by sections 17 (4) and 25 (3) of the Reserve Forces Act, 1966 section 2 (4) of the Auxiliary Forces Act, 1953, as amended by section 1 (3) of the Defence (Transfer of Functions) Act, 1964 and section 23 (6) of the Reserve Forces Act, 1966, and the Reserve Forces Act, 1966, (Isle of Man) Order 1968, are pleased to Order, and it is hereby ordered as follows:

1. The Territorial and Auxiliary Forces Association for the Isle of Man established by the Isle of Man Association Scheme, 1947, hereinafter referred to as "the old Association" shall be dissolved, and the functions hitherto exercisable by the old Association shall be transferred to an Association to be called the Territorial Auxiliary and Volunteer Reserve Association for Lancashire, Cheshire and the Isle of Man hereinafter referred to as "the successor Association".

2.—(1) All property, real and personal (including interests in property, things in action and rights) held or enjoyed by or vested in the old Association on the date of the coming into operation of this Order and all liabilities then incumbent on the old Association shall by virtue of this Order be transferred from the old Association to and be vested in the successor Association, subject as regards any such property to any charges thereon and subject to the same trusts and conditions (if any) to which the said property was subject whilst vested in the old Association and the successor Association shall discharge all such liabilities.

(2) Any instrument shall have effect, so far as may be necessary for or in consequence of the transfers effected by this Order, as if references to the old Association or to officers of the old Association (including any reference which is to be construed as such a reference) were references to the successor Association or to officers of the successor Association, as the case may be.

3. Without prejudice to the generality of the preceding provisions of this Order, where, by the operation of any of the said provisions, any right or liability becomes a right or liability of the successor Association, the successor Association and all other persons shall, as from the date of the coming into operation of this Order, have the same rights, powers and remedies (and in particular the same rights and powers as to the taking or resisting of legal proceedings or the making or resisting of applications to any authority) for ascertaining, perfecting or enforcing that right or liability as they would have had if it had at all times been a right or liability of the successor Association, and any legal proceedings or applications to any authority pending on the date of the coming into operation of this Order by or against the old Association in so far as they relate to any property, right or liability transferred to the successor Association under this Order shall be continued by or against the successor Association to the exclusion of the old Association.

4.—(1) Any officer or member of the staff of the old Association who has not been given notice terminating his employment the termination taking effect on or before the coming into operation of this Order shall be in the employment of the successor Association with effect from the date of the coming into operation of this Order:

(2) A change of employment by virtue of paragraph (1) of this Article shall not affect any right

or obligation of a person whose employment is changed without the consent of that person save as provided in Article 2 of this Order.

5. This Order shall come into operation on the 24th October 1968.
