## WATER ACT 1945

1. Notice is hereby given that the Minister of Housing and Local Government is about to make an Order under section 9 (2) of the Water Act 1945, consti-tuting a joint water board with limits of supply comprising the following areas in the county of Norfolk:

The borough of Thetford,
The urban districts of Diss, East Dereham, Swaff-ham and Wymondham,

The rural districts of Depwade, Swaffham and Wayland,

In the rural districts of Forehoe and Henstead the parishes of Deopham, Hingham, Kimberley, Morley and Wicklewood.

In the rural districts of Mitford and Launditch the parishes of Cranworth, Fransham, Garvestone, Great Dunham, Gressenhall, Hardingham, Little Dunham, Scarning, Shipdham, Wendling, Whinburgh and Yaxham.

- 2. The Board, which would be known as the South Norfolk Water Board, would be responsible for water supply in the above areas, would take over the existing water supply undertakings in those areas, and would supply water at not more than the appropriate maximum rates and charges laid down in the Order.

## **NEW TOWNS ACT 1965**

The Dawley New Town (Designation) Amendment (Telford) Order 1968

Notice is hereby given that the Minister of Housing and Local Government, in exercise of his powers under sections 1 and 53 of the New Towns Act under sections 1 and 53 of the New Towns Act 1965 and of all other powers enabling him in that behalf, on the 29th November 1968, made an Order varying the Dawley New Town (Designation) Order 1963, by adding to the area thereby designated an area of about 10,143 acres of land lying within the urban districts of Oakengates and Wellington and the rural districts of Shifnal and Wellington in the

administrative county of Salop as shown on the map referred to in the Order.

2. In compliance with the provisions of paragraph 5 of Schedule 1 to the Act a copy of the Order and a copy of the map have been deposited at the following places where they may be inspected at all reasonable hours without payment of fee:

- 5. Paragraph 6 of Schedule 1 to the New Towns Act 1965 provides that if any person aggrieved by an Order under section 1 of the Act desires to question the validity thereof, or of a provision contained therein, on the ground that it is not within the powers of the Act or that any requirement of the Act has not been complied with in relation to the Order, he may, within six weeks from the date on which notice of the making of the Order is first published, make an application to the High Court: published, make an application to the High Court; and on any such application the Court—
  - (a) may by interim order suspend the operation of
  - (a) may by interim order suspend the operation of the Order or any provision contained therein, either generally or in so far as it affects any property of the applicant, until the final determination of the proceedings; and
    (b) if satisfied that the Order or any provision contained therein is not within the powers of the Act or that the interests of the applicant have been substantially prejudiced by any requirement of the Act not having been complied with, may quash the Order or any provision contained therein, either generally or in so far as it affects any property of the applicant.
