(e) Prohibit vehicles waiting (1) between the hours of 8 a.m. and 7 p.m. Mondays to Saturdays on that part of Middle Gate (a) from its junction with Boar Lane for a distance of 23 yards south-westwards (b) from its junction with Kirk Gate for a distance of 25 yards south-westwards on the north-west side and 22 yards south-westwards on the south-east side. (2) On the remainder of Middle Gate on the (a) south-east side for more than 40 minutes in one hour between the hours of 8 a.m. and 7 p.m. Mondays to Saturdays on those days of the month which bear odd number (b) north-west side for more than 40 minutes in one hour between the hours of 8 a.m. and 7 p.m. Mondays to Saturdays on those days of the month which bear even number. number.
