ter—Bangor Trunk Road (East of Abergele to County Boundary) Order 1971 The Chester-

The Secretary of State hereby gives notice that he has made an Order under section 7 and paragraph 29 of Schedule 24 to the above Act providing:

- (a) that the highways he proposes to construct east of Abergele in the County of Denbigh shall become trunk roads as from the date when the Order comes into operation, and
 (b) that the lengths of the Chester—Bangor Trunk
- (b) that the lengths of the Chester-Bangor Trunk Road to be superseded shall cease to be trunk roads as from the 1st April next after the date on which notice is given by the Secretary of State to the County Council of Denbigh (who will become the highway authority responsible for those lengths) that the new trunk roads are open for through traffic; and (c) that the Chester-Bangor Trunk Road (Coed Bodtegwal and Pen-y-Ffordd Diversions). Order 1938 shall be revoked.
