ROAD TRAFFIC ACTS

BASINGSTOKE BOROUGH COUNCIL

The Borough of Basingstoke (Controlled Traffic Zone) (Prohibition of Waiting, Loading and Un-loading) Order 1971.

Notice is hereby given that on the 25th January 1972, the Basingstoke Borough Council made the above-named Order under section 1 (1), (2), (3), (3C) and 84D (1) of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, for the purpose of a general scheme of traffic control within the area stated in Schedule 1 to this notice. The Order:

- (a) prohibits the waiting of vehicles at all times in the roads and lengths and sides of roads (within the stated area) described in Schedule 2 to this notice.
- (b) prohibits the waiting of vehicles between the hours of 8 a.m. and 7 p.m. on any day other than a Sunday in all other roads and lengths and sides of roads within the stated area, except for the roads and length of road described in Schedule 3 to this notice which are excluded from the Order.

Exceptions (which may be seen in full in the Order) permit waiting for the purpose of:

- (a) picking up and setting down passengers;
 (b) loading and unloading goods, with the exception of the lengths of roads described in Schedule 4 to this notice where loading and unloading is prohibited between the hours of 8 a.m. and 9.30 a.m., 12 noon and 2 p.m. and 4 p.m. and 6 p.m.;
 (c) the maintenance of roads;
 (d) the supply of gas, electricity and water;
 (e) the taking of petrol, oil, water or air from garages.

Hackney carriages waiting whilst plying for hire at authorised hackney carriage stands are exempt. Vehicles waiting upon authorised parking places

are exempt.

Invalid carriages, vehicles issued by the Depart-tent of health and Social Security in lieu of an ment ment of health and Social Security in lieu of an invalid carriage, vehicles kept and used by disabled persons which bear yellow badges or a notice issued by the Council, vehicles the driver of which has been given a certificate by the Council granting exemption in regard to any specific place named in the certificates, and vehicles driven by doctors, midwives or nurses whilst engaged on professional visits, are exempt. A copy of the Order which shall come into opera-tion on the 31st January 1972, and a map showing the nature and extent of the restrictions, are available for inspection free of charge, Mondays to Fridays, between 9 a.m. and 4.30 p.m. at my office.

Any person who desires to question the validity of the Order or of any provision contained in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, or on the grounds that any requirement of that Act or of any instrument made under it has not been complied with in relation to the Order, may within 6 weeks from the 25th January 1972, apply to the High Court for this purpose.
