NOTICE OF APPLICATION TO VARY
A LICENCE TO ABSTRACT WATER

Notice is hereby given that an application is being made to the Essex River Authority by Donald Byford, of Thurcaston Grange, Leicester, to vary licence (serial number 8/36/13/15) to abstract water from a borehole sunk in chalk at the Rookery Farm, Acton, Suffolk, National Grid Map Ref.: TL896469.

The variation applied for is the provision of domestic water supply to the privately-owned former farm house (requiring 300 gallons a day). Also additional supply for the cattle and stock, thus increasing the daily output from 2,000 gallons to 3,500 gallons in all.

ABSTRACT WATER

Notice is hereby given that the Avon and Dorset River Authority have deposited proposals for licences to abstract the following quantities of water for the purposes of fish hatcheries (game fish breeding and stocking at the following points of abstraction:

- (1) 96,000 gallons per day and 16,416,000 gallons per year from a Well in the Chalk at Standlynch Mill in the Parish of Downton, near Salisbury, Wiltshire. (Grid Reference SU 181 236.)
- (2) 6,500,000 gallons per day and 2,372,500,000 gallons per year from the River Avon at Standlynch in the Parish of Downton, near Salisbury, Wiltshire. (Grid Reference SU 181 236.)
- (3) 19,200 gallons per day and 3,000,000 gallons per year from the River Avon at Standlynch in the Parish of Downton, near Salisbury, Wiltshire. (Grid Reference SU 181 236.)

- (5) 84,000 gallons per day and 15,330,000 gallons per year from the Ripley Brook at Park Hill, Sandford, in the Parish of Ringwood, Hampshire. (Grid Reference SU 176 022.)

Notice is hereby given that:
