

HEREFORDSHIRE COUNTY COUNCIL

The Herefordshire County Council (Various Streets, Ledbury) (Prohibition and Restriction of Waiting) (Amendment) Order 1973

Notice is hereby given that on the 19th February 1973 the Herefordshire County Council made an Order under Section 1 of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968 varying the provisions of the Herefordshire County Council (Various Streets, Ledbury) (Unilateral, Prohibition and Restriction of Waiting) Order 1965.

The effect of the Order, which will come into operation on the 1st April 1973, will be:

- (a) to prohibit the waiting of vehicles in any of the lengths of road in the Town Parish of Ledbury specified in Schedule 1 to this notice; and
- (b) to restrict the waiting of vehicles to a period of not more than 45 minutes, between the hours of 8 a.m. and 6 p.m. in any of the lengths of road in the Town Parish of Ledbury specified in Schedule 2 to this notice.

Exceptions will permit waiting for the purpose of picking up and setting down passengers, loading and unloading goods and the maintenance of roads and other essential public services.

A copy of the Order and relevant map may be inspected during normal office hours at the Shirehall, Hereford and at the office of the Clerk to the Ledbury Rural District Council, St. Katherine's, Ledbury.

If you wish to question the validity of the Order or of any provision contained in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, or on the grounds that any requirement of the Act or any instrument made under it, has not been complied with in relation to the Order, you may within six weeks from the 19th February, 1973, apply to the High Court for this purpose.

SCHEDULE 1

1. *The Homend*,
West side, from its junction with Belle Orchard for a distance of 27 yards in a southerly direction;
East side, from its junction with Church Street to a point opposite its junction with Orchard Lane.
2. *Bye Street*, from its junction with High Street for a distance of 117 yards in a westerly direction.
3. *High Street*,
West side, from its junction with Bye Street for a distance of 20 yards in a southerly direction and from its junction with New Street for a distance of 25 yards in a northerly direction;
East side, from its junction with Worcester Road for a distance of 25 yards in a northerly direction.
4. *The Southend*,
West side, from its junction with New Street for a distance of 183 yards in a southerly direction;
East side, from its junction with Worcester Road for a distance of 66 yards in a southerly direction.
5. *Church Street*, from its junction with High Street to its junction with Homend Crescent including the spur road from the south side of Church Street to the Church gates.
6. *Bank Crescent*,
North side, from its junction with the Homend to its junction with Homend Crescent;
South side, from its junction with the Homend for a distance of 37 yards.

SCHEDULE 2

1. *The Homend*, west side, from its junction with Orchard Lane to its junction with Belle Orchard; and from a point 27 yards south of its junction with Belle Orchard to its junction with Bye Street.
2. *High Street*,
West side, from a point 20 yards south of its junction with Bye Street for a distance of 13 yards in a southerly direction; and from a point 25 yards north of its

junction with New Street for a distance of 75 yards in a northerly direction;

East side, from a point 25 yards north of its junction with Worcester Road for a distance of 68 yards in a northerly direction. (365)

The Herefordshire County Council (Corn Square, Leominster) (Prohibition and Restriction of Waiting) (Amendment) Order, 1973

Notice is hereby given that on the 19th February 1973, the Herefordshire County Council made an Order under Section 1 of the Road Traffic Regulation Act, 1967, as amended by Part IX of the Transport Act, 1968, varying the provisions of The Herefordshire County Council (Corn Square, Victoria Street and Burgess Street, Leominster) (Prohibition of Waiting) Order, 1965 and The Herefordshire County Council (Corn Square, Leominster) (Restriction of Waiting) Order, 1966.

The effect of the Order, which will come into operation on the 1st April 1973, will be (a) that the prohibition on the waiting of vehicles on the east, west and south sides of Corn Square, Leominster contained in the Order of 1965, and the restriction on the waiting of vehicles in the centre part of and on the north side of Corn Square, Leominster, contained in the Order of 1966, will not be operative on any Thursday after 12 o'clock noon and on any Sunday; and (b) that the prohibition on the waiting of vehicles on the south side of Corn Square, Leominster, for a distance of three yards from its junction with the east side of Corn Square, Leominster, will be replaced by a restriction on the waiting of vehicles.

A copy of the Order and a map showing the lengths of road to which it relates may be inspected during normal office hours at the Shirehall, Hereford, and at the office of the Town Clerk, Grange Court, Leominster.

Any person who desires to question the validity of the Order or of any provision contained in it on the ground that it is not within the power of Section 1 of the said Act or on the ground that any requirement of that section or of sections 84A, 84B or 84C of the Act, or any regulations made under the said section 84C, has not been complied with in relation to the Order, may, within six weeks of the 19th February, 1973, make application for the purpose to the High Court.
