Llanelli Corporation Traffic Regulation (General No. 1) Order 1973

Exceptions will permit waiting for the purposes of:

- Picking up and setting down passengers;
- Loading or unloading goods and, where necessary, in connection with—
- The maintenance of the road, and
- The supply of Gas, Electricity and Water, and telephone services.

Exceptions are also made in favour of certain classes of vehicles including inter alia invalid carriages.

4. *8 a.m. to 7 p.m.—daily*

- (a) *Pitt Street* (west side only) for 50 metres from Fishergate.
- (b) *Butler Street* (east side only) for 80 metres from Fishergate.
- (c) *Theatre Street* (east side only) from a point 25 metres from Fishergate for 15 metres southwards.
- (d) *Deepdale Road* (west side only) from a point 15 metres north from Argyll Road for 39 metres northward.

5. *Weight Restriction—3 tons laden or unladen.*

Ridley Road between Blackpool Road and Roebuck Street.

Exceptions will be provided in the first mentioned Order to enable a vehicle to wait for so long as may be necessary for a person to board or alight from the vehicle, or to enable goods to be loaded or unloaded from a commercial vehicle or to enable the vehicle to be used in connection with any funeral, building operation or demolition, the removal of any obstruction to any traffic, the maintenance of roads or the services therein.
