## **CUSTOMS AND EXCISE**

NOTICE OF SEIZURE UNDER THE CUSTOMS AND EXCISE ACT, 1952

To: MOHINDER KAUR VIRDEE c/o Amar Singh Nandhra, PO Box 428, Nakuru, Kenya.

Pursuant to section 275 (5) of the Customs and Excise Act, 1952, and paragraph 1 of the 7th Schedule therto, the Commissioners of Customs and Excise hereby give you notice that by virtue of the powers contained in the Customs and Excise Acts and enactments amending those Acts, certain goods, namely: one pair of gold snake bangles, eight gold bangles, one gem set gold pendant enamel centre and one gem set gold pendant imported by Mohinder Kaur Virdee at Heathrow in or before December 1972, have been seized as liable to forfeiture upon the grounds that:

- The said jewellery being goods chargeable with a duty of customs had without payment of that duty been removed from its place of importation.

The Wallasey (Liscard) Smoke Control Order No. 18, 1973

If confirmed the Order will not come into operation before the 1st November 1974, or before a later date determined by the Secretary of State of the Department of the Environment.
