BY THE QUEEN A PROCLAMATION

REVOKING A PROCLAMATION, DATED THE 6TH DAY OF MARCH 1974, DECLARING THE EXISTENCE OF A STATE OF EMERGENCY

Whereas by Our Proclamation, dated the 6th day of March 1974, We declared that the continuation of the industrial dispute affecting persons employed in the coal mines did, dispute affecting persons employed in the coal mines did, in Our opinion, constitute a state of emergency within the meaning of the Emergency Powers Act 1920, as amended by the Emergency Powers Act 1964:

And Whereas it appears to Us that the state of emergency has now ceased to exist and that it is expedient that the said Proclamation should be revoked accordingly:

Now, Therefore, We, by and with the advice of Our Privy Council, hereby proclaim that the said Proclamation is revoked

Given at Our Court at Buckingham Palace this eleventh day of March in the year of our Lord One thousand nine hundred and seventy-four, and in the twenty-third year of Our Reign.
