The Trunk Road (Builth Wells) (Bus Stops) (Clearway) Order 1974

Notice is hereby given that the Secretary of State intends to make an Order under section 1 of the Road Traffic Regulation Act, 1967, as amended by Part IX of the Transport Act, 1968.

The purpose of the Order is to prohibit vehicles, other than buses, from waiting between 7 a.m. and 7 p.m. on any day at any bus stop in the length of road specified below where the carriageway at that stop is marked (a) as a bus stop, and (b) with a broad yellow line adjacent to the edge of the carriageway ("the authorised markings").

Although the Order includes every bus stop in the length of road specified below, it should be noted that the provisions of the Order which prohibit waiting will apply only to those bus stops which the Secretary of State marks with the authorised markings.

While the Order remains in force it enables the Secretary of State at any time to lay or remove the authorised markings at or from any bus stop in the specified length of road or to adjust the position in that length of road of the authorised markings, as traffic conditions may require.

Other vehicles will be permitted to wait at the bus stops with authorised markings where necessary for—

- (1) the removal of an obstruction to traffic,
- (2) the maintenance of the road and in exercise of statutory powers with permission of the local authority, and
- (3) reasons of emergency.

That length of the Swansea—Manchester Trunk Road (A.483), known as The Strand, at Builth Wells in the County of Brecon, which extends from its junction with Strand Street in a north-easterly direction to its junction with Groe Street.

Y SWYDDFA GYMREIG

The Trunk Road (The Street, Brecon) (Prohibition and Restriction of Waiting) Order 1974

Notice is hereby given that the Secretary of State intends to make an Order under section 1 of the Road Traffic Regulation Act, 1967, as amended by Part IX of the Transport Act, 1968, the effect of which will be:

- (i) to restrict waiting to 30 minutes in any one hour between the hours of 8 a.m. and 6 p.m. on any day other than Sunday on the side of road specified in Schedule 1 to this notice;
- (ii) to prohibit waiting on those sides of road specified in Schedule 2 to this notice.

Exceptions will be provided in the Order to enable a vehicle to wait for so long as may be necessary for a person to board or alight from the vehicle; to enable goods to be loaded onto or unloaded from the vehicle; to enable the vehicle to be used in connection with any building operation or demolition, the removal of any obstruction to traffic, the maintenance of the road or services therein; or to enable the vehicle to take in petrol, oil, water or air from any garage situated on or adjacent to any of the said sides of road; or to enable the vehicle to be used in the service of a local authority in pursuance of statutory powers or duties.

Also exceptions will be provided in the Order to allow invalid vehicles and vehicles bearing a disabled person's badge to wait for as long as may be necessary on the side of road specified in Schedule 1 to this notice.
