SOUVENIRS

THE QUEEN'S SILVER JUBILEE
1952-1977

With reference to the Memorandum issued by the Lord Chamberlain, and published in the *London Gazette* of Tuesday, 13th January 1976, conveying The Queen's approval for the temporary relaxation of the Rules governing the commercial use of Royal Photographs and Insignia on souvenirs of Her Majesty's Silver Jubilee, the Lord Chamberlain has now authorised the following amendment to paragraph 7 of this Memorandum headed "Limitations of Use":

(b) Delete: 1st January 1977.
Insert: 15th November 1976.

Paragraph 7(b) should therefore now read:

"Souvenirs of The Queen's Silver Jubilee produced by authority of these instructions may not be sold to the public before the 15th November 1976, nor manufactured after the 1st October 1977."

The Trunk Road (Buttington Bridge, Powys) (Temporary Prohibition of Traffic) Order 1976

Notice is hereby given that to enable works to be carried out the Secretary of State for Wales intends to make an Order under section 12(1) of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, the effect of which will be that no person shall on Sunday, 4th April 1976, from 10 hours until 15 hours on that same day, cause any vehicle to proceed in that length of the Shrewsbury—Dolgellau Trunk Road (A.458) which extends from the western abutment of Buttington Bridge, near Welshpool, in the County of Powys, to the western gate of Buttington Bridge Level Crossing.

The alternative route for through traffic travelling in an easterly direction is:

from The Cross Welshpool travel eastwards along the B.4381 to Lower Leighton Farm then northwards along the B.4388 to meet the A.458, 163 yards east of Buttington Bridge Level Crossing.

The alternative route for traffic travelling in an easterly direction is vice versa.
