THE INTER-AMERICAN DEVELOPMENT BANK (IMMUNITIES AND PRIVILEGES) ORDER 1976

Y SWYDDFA GYMREIG TOWN AND COUNTRY PLANNING ACT 1971

The Secretary of State for Wales hereby gives notice that he has made an Order under section 209 of the Town and Country Planning Act 1971 to authorise the stopping up of lengths of highway described in the Schedule to this notice, to enable development to be carried out in accordance with planning permission granted under Part III of that Act

The Order requires the provision of a new highway maintainable at the public expense, for which the highway authority will be the Mid Glamorgan County Council.

Copies of the Order may be obtained, free of charge, on application to the Secretary of State, Welsh Office (Y Swyddfa Gymreig), Transport and Highways Group, Government Buildings, Ty Glas Road, Llanishen, Cardiff, CF4 5PL (quoting the reference WR15/52/4) and may be inspected at all reasonable hours at the offices of the Merthyr Tydfil Borough Council, Town Hall, Merthyr Tydfil.

Any person aggrieved by the Order and desiring to question the validity thereof, or of any provision contained therein, on the grounds that it is not within the powers of the above Act or that any requirement of that Act or of any regulations made thereunder has not been complied with in relation to the Order, may, within 6 weeks of the 19th August 1976, apply to the High Court for the suspension or quashing of the Order or of any provision contained therein.

The lengths of highway to be stopped up are at Cefn Coed-y-Cymmer in the Borough of Merthyr Tydfil in the County of Mid Glamorgan. They are:

- that length of Cross Street, which extends from its junction with High Street in a south-westerly direction for a distance of 7 yards, and
- that length of Field Street, which extends from its junction with High Street in a south-westerly direction for a distance of 22 yards.
