The Queen has been graciously pleased to ordain and declare that Anne Rhoda Marsham shall henceforth have, hold and enjoy the same title, rank, place pre-eminence and precedence as the daughter of an Earl which would have been due to her had her father the Honourable Reginald Hastings Marsham, O.B.E., Lieutenant Colonel in the Army, who died on 8th November 1922 survived his nephew Charles Earl of Romney and thereby succeeded to the title and dignity of Earl of Romney.

And to command that the said Royal Concession and Declaration be recorded in Her Majesty's College of Arms.
