2. The Bills will be in amounts of £5,000, £10,000 £25,000, £50,000, £10,000 or £1,000.000. They will be dated at the option of the tenderer on any business day from Monday the 20th December 1976, to Friday the 24th December 1976 inclusive, and will be due 91 days after date.

4. Each Tender must be for an amount not less than £50,000 and must specify the date on which the Bills required are to be dated and the net amount per cent. (being a multiple of one new halfpenny) which will be given for the amount applied for. Separate Tenders must be lodged for Bills of different dates.

5. Tenders must be made through a London Banker, Discount House or Broker.

6. Notification will be sent on the same day as Tenders are received to the persons whose Tenders are accepted in whole or in part.
