TOWN AND COUNTRY PLANNING ACT 1971

Lady Herbert's Garden and Greyfriars Green Conservation Areas

Notice is hereby given that Coventry City Council, as local planning authority, under the Town and Country Planning Act 1971, have designated under section 277, Town and Country Planning Act 1971, as conservation areas, extensions to Lady Herbert's Garden Conservation Area and to Greyfriars Green Conservation Area.

The objects of such designation are to preserve the character or appearance of areas of special architectural or historic interest as distinct from the preservation of individual buildings to control development in such areas and to encourage measures to improve the environment.

Within the designated areas the consent of the appropriate local planning authority must be obtained before any building is demolished or partially demolished. It is also necessary to give the authority 6 weeks notice in writing before any tree in the designated area is cut down, uprooted, topped, lopped, wilfully destroyed or damaged, in both cases limited works are permitted, but information on this should be obtained from the Council as local planning authority (Department of Architecture and Planning).

Lady Herbert's Garden Conservation area lies $\frac{1}{2}$ kilometre ($\frac{1}{2}$ mile) north of the city centre and contains the two remaining city gates and a part of the city wall which are scheduled as Ancient Monuments. The extension covers an area up to the Inner Ring Road which has been landscaped.

The extension increases the conservation area from 1.3 hectares (3.2 acres) to 1.9 hectares (4.7 acres). The area extends a distance of 220 metres (240 yards) from Hales Street to Henry Street.

Greyfriars Green Conservation Area lies $\frac{1}{2}$ kilometre ($\frac{3}{4}$ mile) south west of the City Centre and contains 17 early 19th century dwellings and 10 mid-19th century dwellings, which are now shops and offices, listed Grade II. The extension includes the area added to the green up to the Inner Ring Road which has been landscaped, and deletes the area appropriated to the Inner Ring Road.

The extension increases the conservation area from 3 hectares (7.5 acres) to 3.2 hectares (7.9 acres).

Plans and detailed descriptions of the areas are available for public inspection during normal office hours at the Department of Architecture and Planning, Tower Block, New Council Offices, Coventry, and copies are available on request.

The Leominster District Council (Bodenham) Public Path Diversion Order, 1977

Notice is hereby given that on the 30th March 1977, the Leominster District Council confirmed the above-named Order.

The effect of the Order as confirmed is to divert the public right of way being part of Footpath No. B.M. 11 on the Definitive Map commencing at its junction with the Class III road leading from Sutton St. Nicholas to England's Gate in the County of Hereford and Worcester and running therefrom in a westerly direction for a distance of 123 metres or thereabouts to a new line commencing near the eastern boundary of Parcel O.S. No. 602 and ending at the western end of the length of the said footpath to be diverted.

A copy of the confirmed Order and the map contained in it has been deposited at and may be inspected free of charge at the offices of the Leominster District Council, M.E.B. Buildings, West Street, Leominster, between 9 a.m. and 4.30 p.m. on normal working days.

This Order becomes operative on the 30th March 1977, but if any person aggrieved by the Order desires to question the validity thereof or of any provision contained therein on the grounds that it is not within the powers of the Town and Country Planning Act 1971, or on the ground that any

requirement of that Act or any regulation made thereunder has not been complied with in relation to the confirmation of the Order, he may, under section 244 of the Town and Country Planning Act 1971, within 6 weeks from the 6th May 1977, make application for the purpose to the High Court.

The Leominster District Council (Aymestrey) Public Path Diversion Order, 1977

Notice is hereby given that on the 27th April 1977, the Leominster District Council confirmed the above-named Order.

The effect of the Order as confirmed is to divert the public right of way being part of Footpath No. A.Y. 7 on the Definitive Map commencing at the north-western corner of Parcel No. 1923 National Grid Sheet 42-4366 in the Parish of Aymestrey in the County of Hereford and Worcester and running therefrom in a southerly and then in a south-easterly direction for a distance of 619 metres or thereabouts to Beech Grove to a new line commencing at the northern end of the length of public footpath to be diverted and ending at the south-eastern end of the length of the said footpath to be diverted.

NOTICE OF PUBLIC PATH ORDER

West Lindsey District Council (Footpath No. 131 North Greetwell) (No. 1) Public Path Diversion Order, 1977

Notice is hereby given that the above-named Order (hereinafter referred to as "the Order") made on the 19th May 1977 is about to be submitted to the Department of the Environment for confirmation or to be confirmed by the West Lindsey District Council as an unopposed Order.

The effect of the Order, if confirmed without modification, will be to extinguish the public right of way running in a north-westerly to south-easterly direction from the southern end of Westfield Avenue, North Greetwell, across Field No. 6953 for a distance of approximately 210 metres to the boundary with Field No. 0034 and create an alternative highway running along the newly constructed tarmac footpath on the western side of the roundabout at the southern end of Westfield Avenue, North Greetwell for a distance of approximately 50 metres and then proceeding in a south-south-easterly direction for a distance of approximately 126 metres and then in an easterly direction for a distance of approximately 60 metres and joining with the remaining length of footpath No. 131 at the boundary of Field No. 0034 (O.S. National Grid Plan No. TF0073-1073).
