HIGHWAYS ACTS 1959 to 1971

The Chester-Bangor Trunk Road (Sandy Lane, Saltney Detrunking) Order 1977

The Secretary of State for Wales hereby gives notice that he has made an Order under section 7 of the Highways Act 1959 providing that a length of the Chester-Bangor Trunk Road known as Sandy Lane and situated at Saltney in the County of Clwyd ceased to be a trunk road as from the date when the Order came into operation.
