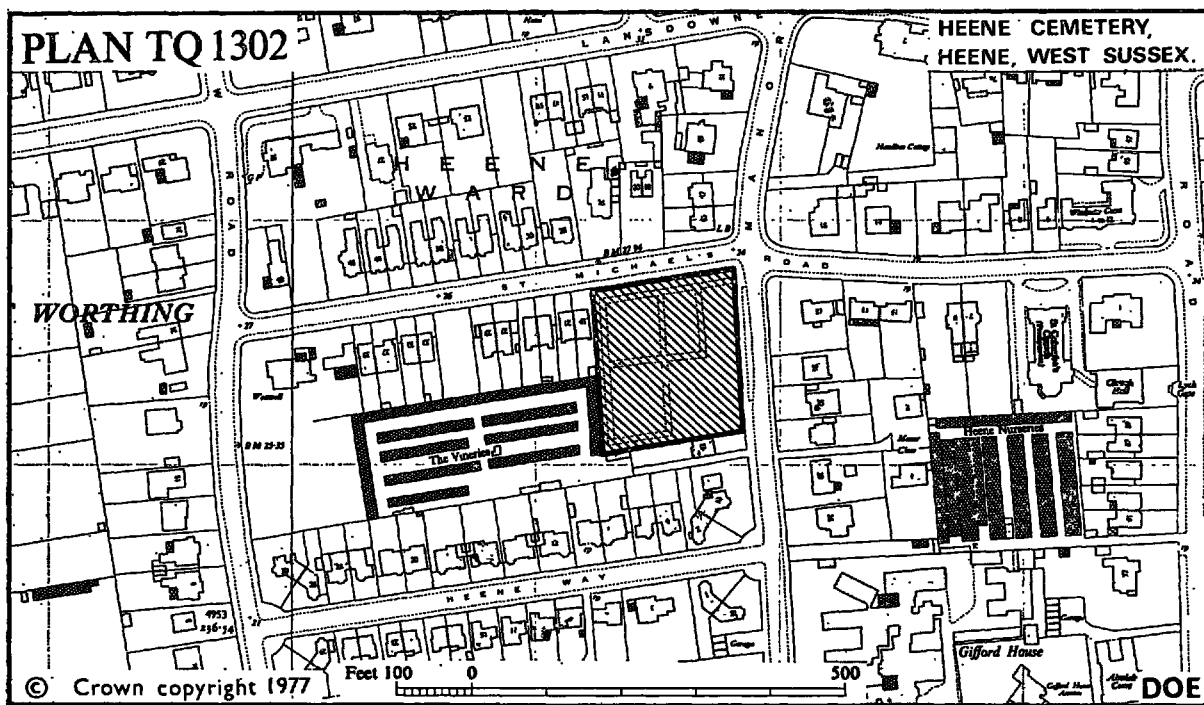

Payment in full of the amounts due in respect of such accepted Tenders must be made to the Bank of England by means of cash or by draft or cheque drawn on the Bank of England not later than 1.30 p.m. on the day on which the relative Bills are to be dated.

Imposition of 40m.p.h. Speed Limit

That length of the Swansea-Manchester Trunk Road (A56) at Stretford in the Borough of Trafford in the county of Greater Manchester which extends from a point 330 yards south of Chapel Lane to a point 66 yards south of Davyhulme Road East.

The Trunk Road (Cheltenham Road, Gloucester) (Traffic Regulation) Order 1978

The Secretary of State for Transport has made an Order under sections 1 and 84D of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968 on the London-Fishguard Trunk Road (A40) on Cheltenham Road, in the City of Gloucester in the county of Gloucestershire.

The effect of the Order which comes into operation on 30th March 1978 is to revoke and reimpose the provisions of the Trunk Road (Cheltenham Road, Gloucester) (Traffic Regulation) Order 1972 with the addition of an exemption as required by the Local Authorities' Traffic Orders (Exemptions for Disabled Persons) (England and Wales) (Amendment) Regulations 1975, which will permit disabled persons' vehicles to wait in that length of the trunk road specified in the Order for 2 hours with no return within one hour.
