Notice of Seizure under the Customs and Excise Act 1952 To: UNITED CREATRON LIMITED, Suite No. 905A, Shui Hing House, 23-25 Nathan Road, Kowloon, Hong Kong.

Pursuant to section 275 (5) of the Customs and Excise Act 1952 and paragraph 1 of the 7th Schedule thereto, the Commissioners of Customs and Excise hereby give you notice that by virtue of the powers contained in the Customs and Excise Acts and enactments amending those Acts, certain goods, namely 2991 "Binaton" Model 01-9755 monochrome television set receivers with cathode ray tubes of a bulb diagonal measurement of 12 inches and one box of television spare parts, all originating in Taiwan and imported at Southampton on 10th September 1977 have been seized as liable to forefeiture upon the grounds that:

- The said goods were imported into the United Kingdom in contravention of Article 1 of the Import of Goods (Control) Order 1954 made under Section 1 of the Import, Export and Customs Powers (Defence) Act 1939.

Whereby and by force of section 3 (1) of the Import Export and Customs Powers (Defence) Act 1939 and Section 44 (b) of the Customs and Excise Act 1952 the said goods are liable to forfeiture.

If you claim that the said goods are not liable to forfeiture you must within one month from the date of this notice of seizure give notice of your claim in accordance with the said Schedule to the said Act specifying the name and address of a solicitor in England and Wales who is authorised to accept service of process and to act on your In default of such notice the said goods will be deemed to have been duly condemned as forfeited and will be liable to be disposed of in such manner as the Com-missioners of Customs and Excise may direct. If you make such claim within the time aforesaid, legal proceedings will be taken for the condemnation thereof.
