## PUBLIC HEALTH ACTS AND CLEAN AIR ACT

### HARTLEPOOL BOROUGH COUNCIL

#### THE CLEAN AIR ACT 1956

*The Borough of Hartlepool (No. 34 Smoke Control) Order 1978*

Notice is hereby given that Hartlepool Borough Council in exercise of the powers conferred upon them by section 11 of the above-mentioned Act on 5th June 1978 made an Order entitled "The Borough of Hartlepool No. 34 Smoke Control Order 1978" declaring the area described in the Schedule hereto to be a smoke control area, which Order is about to be submitted to the Secretary of State for the Environment for confirmation.

Subject to the exemption provided by the Order and by virtue of section 11(4) of the Act if on any days after the Order has come into operation smoke is emitted from a chimney of any building within the smoke control area the occupier of that building shall be guilty of an offence and liable to a fine not exceeding £20 unless he proves that the emission of smoke was not caused by the use of any fuel other than authorised fuel. The authorised fuels include anthracite, coke and other carbonised fuels, gas and electricity.

If confirmed, the Order will not come into operation before 1st July 1979 or before a later date determined by the Secretary of State for the Environment.

Copies of the Order and of the map referred to therein may be inspected free of charge at the offices of the Borough Solicitor, Civic Centre, Victoria Road, Hartlepool during normal office hours during the period of 6 weeks from 23rd June 1978.

Within the said period any person who will be affected by the Order may by notice in writing to the Secretary of State for the Environment, 2 Marsham Street, London, SW1P 3EB object to the confirmation of the Order.

## ROAD TRAFFIC ACTS

### AVON COUNTY COUNCIL

*The County of Avon (City of Bath) (Bailbrook Lane) (Prohibition of Driving) Order 1978*

Notice is hereby given that on 20th June 1978 the County Council of Avon made an Order under section 1 (1), (2) and (3) of the Road Traffic Regulation Act 1967, as amended, the effect of which is to prohibit any motor vehicle entering or proceeding on the entire length of Bailbrook Lane.

Exemptions in the Order permit any vehicle to use that road for the conveyance of persons, goods or merchandise to or from any premises situated on or adjacent to the road; in connection with building operations or the repair and maintenance of the road or services therein; for the purposes of agriculture and for fire brigade, police or ambulance purposes.

The Order will come into operation on 26th June 1978 and a copy thereof together with a map may be inspected at the under-mentioned offices (Sixth Floor) during the hours of 8.30 a.m. to 5 p.m. on Mondays to Thursdays and 8.30 a.m. to 4.30 p.m. on Fridays and at the Guildhall, Bath by telephone appointment (28411, extension 266).

Any person who desires to question the validity of the Order or of any provision contained in it on the grounds that it is not within the powers of the relevant section of the Road Traffic Regulation Act 1967, as amended, or on the grounds that any requirement of that Act or of any instrument made under it has not been complied with in relation to the Order, may within 6 weeks after the date on which the Order was made, apply to the High Court for this purpose.

### BERKSHIRE ROYAL COUNTY COUNCIL

*The Royal County of Berkshire (Hythe End Bridge, Wraysbury) (Experimental Prohibition of Commercial Vehicles of Over 5 Tons) Order 1978.*
