supply of any controlled drug within the meaning of that

This Direction does not extend to the doing of anything in circumstances in which it might lawfully be done without being a doctor.

Town and Country Planning Act 1971

The lengths of highway are at Cardiff in the County of outh Glamorgan. They are shown by Zebra Hatching South Glamorgan. on the deposited plan and are:

- (i) that length of the highway known as Canal Street which extends from its junction with Hill's Terrace in a north-easterly direction to its junction with Frederick Street, a total distance of 47 yards;
