BURY METROPOLITAN BOROUGH COUNCIL

Greater Manchester County (Cuckoo Lane, Bury) (Prohibition of Driving) (Borough) Order 1979

CHELMSFORD BOROUGH COUNCIL

The Borough of Chelmsford (Eves Corner, Danbury) Waiting Restriction Order 1979

Notice is hereby given that on 12th January 1979 the Chelmsford Borough Council acting as duly authorised agent for the Highway Authority made an Order under sections 1 (1), (2) and (3) of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968 and Schedule 19 of the Local Government Act 1972 and all other enabling powers.

When the above Order comes into effect no person shall park any vehicle in the car parking space specified in column 1 of the Schedule hereto during the time specified in column 2 of the said Schedule:

- (a) for a longer period than one hour;
- (b) if a period of less than one hour has elapsed since the termination during the said time of the last period of waiting (if any) of the vehicle in that length of road.

The Order shall come into operation on 5th March 1979 or as soon thereafter as the necessary signs are erected.

CHELMSFORD BOROUGH COUNCIL

CHESTERFIELD BOROUGH COUNCIL

Chesterfield Borough Council (Beetwell Street) (Prohibition of Waiting) (Amendment) Order 1977

Notice is hereby given that on 17th January 1979 the Chesterfield Borough Council made the above Order pursuant to arrangements made under section 101 of the Local Government Act 1972 with the Derbyshire County Council in exercise of the powers of the said County Council under section 1 of the Road Traffic Regulation Act 1967 as amended.

The effect of the Order which will come into operation on 19th February 1979 is to amend the Borough of Chesterfield (Various Streets) (Prohibition of Waiting Order) 1966 so as to prohibit parking at all times and to prohibit loading and unloading before 6 a.m. or after 8 p.m. on a taxi rank which is to be created at the east end of New Beetwell Street. Exceptions will be provided in respect
