

- (b) to a vehicle being used for fire brigade, ambulance or police purposes; or
- (c) in certain circumstances, to a vehicle being used in the service of a local authority, in connection with building operations, etc., adjacent to the bus stop or the removal of an obstruction to traffic or the repair, etc., of the highway or of any service therein; or
- (d) to a vehicle waiting for not more than 2 minutes to enable a person to board or alight or to load or unload his personal baggage. The limit of 2 minutes will not apply if the person has serious difficulty in walking or is blind; or
- (e) where the person in control of the vehicle is required by law to stop or does so in order to avoid an accident; or
- (f) to anything done with the permission or at the direction of a police constable in uniform.

4. A copy of the Order, which will come into operation on 21 May 1979, and of the Bexley (Restriction of Waiting on Bus Stops) (No. 2) Traffic Order 1977, can be inspected during normal office hours on Mondays to Fridays inclusive until the end of 6 weeks from the date on which the Order was made in Room B.21, The County Hall, London SE1 7PB.

The Ealing (Prescribed Routes) (No. 2) Traffic Order 1979

Notice is hereby given that the Greater London Council, on 11th May 1979, made the above-mentioned Order under section 6 of the Road Traffic Regulation Act 1967, as amended by the Transport Act 1968 and the Road Traffic Act 1974.

2. The effect of the Order will be:

- (a) To impose one-way working for vehicular traffic in:
- (i) Islip Manor Road, the north-west to south-west arm, in a south-easterly direction.
- (ii) the unnamed road linking the slip road on the north-east side of Western Avenue with Ealing Road, in a south-easterly direction.
- (iii) the unnamed road linking Kensington Road with the slip road on the south-east side of Western Avenue, in a north-westerly direction.

(b) To prohibit the right turn by vehicles proceeding in a south-westerly direction in Church Road into the service road fronting the Post Office and Nos. 258 to 270 Church Road.

3. Exemption has been provided in the Order in relation to the one-way workings in respect of anything done:

- (a) with the permission or at the direction of a police constable in uniform;
- (b) in accordance with any restriction or requirement indicated by traffic signs placed on the highway by or on behalf of the Metropolitan Police.
