The London Borough of Wandsworth (Lacy Road) (Off-Street Parking Place) Order 1980

WIGAN METROPOLITAN BOROUGH COUNCIL

The Greater Manchester County (Enfield Street, Wigan) (Prohibition of Waiting) (Borough) Order 1979

Notice is hereby given that on 7th March 1980 The Wigan Borough Council ("the Council") made the above-named Order pursuant to arrangements made under section 101 of the Local Government Act 1972 with the County Council of Greater Manchester in exercise of the powers of the County Council under section 1 (1), (2) and (3) of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, Schedule 19 to the Local Government Act 1972 and Schedule 6 to the Road Traffic Act 1974, and all other enabling powers.

The effect of the said Order is to prohibit waiting at any time on the east side of Enfield Street, Wigan, for a distance of 230 metres from a point 50 metres from its junction with Ormskirk Road.

The Order will come into effect on Monday, 31st March 1980.

If you wish to question the validity of the Order or of any provision contained in it on the grounds that it is not within the powers conferred by the aforementioned statutes or on the grounds that any requirement of the said statutes or of any instrument made under them has not been complied with in relation to the Order, you may within 6 weeks from the date of the publication of this notice, apply to the High Court for that purpose.
