TOWN AND COUNTRY PLANNING ACT 1971

The Secretary of State for Wales hereby gives notice that he has made an Order under section 212 of the Town and Country Planning Act 1971 to extinguish any rights which persons may have to use vehicles on a length of Red Street, Carmarthen in the County of Dyfed.

The Order requires the improvement of existing highways. The Order also contains provisions for permitting the use of the said length of Red Street by vehicles being

- (a) for Police, Ambulance or Fire Brigade purposes;
- (b) on behalf of a statutory undertaker, a water authority or the Post Office and engaged on the main-tenance of their apparatus;
- (c) in accordance with a special authorisation for that use given by or on behalf of the Carmarthen District Council, the Dyfed County Council or the Chief Officer of Police for that area.

Copies of the Order may be obtained, free of charge, on application to the Secretary of State, Welsh Office, Transport and Highways Group, Government Buildings, Ty Glas Road, Llanishen, Cardiff CF4 5PL (quoting reference number WR15/21/1) and may be inspected at all reasonable hours at the offices of the Carmarthen District Council, Spilman Street, Carmarthen.

Any person aggrieved by the Order and desiring to question the validity thereof, or any provision contained therein, on the ground that it is not within the powers of the above Act or that any requirement of that Act or of any regulation made thereunder has not been complied with in relation to the Order, may, within 6 weeks of 11th April 1980 apply to the High Court for the suspension or quashing of the Order or of any provision contained therein.

Any person who, at the time of the coming into force of the Order, has an interest in land having lawful access to the highway over which vehicular rights are to be extinguished shall be entitled to be compensated by the Carmarthen District Council as the local planning authority in respect of any depreciation in the value of his interest which is directly attributable to the Order and of any other loss or damage which is so attributable.
