Copenhagen, June 20. N. S. The Danish Forces have been order'd to Holstein are on their March thither; and Yesterday Morning the Troops tha. lay encamped for some time near this Place, filed off towards the Frontiers of Mecklenbourg, in order to join a Body of Saxon Horse, and some Muscovite and Polish Forces in those Parts, where an Army of fixty thousand Men is proposed to be afferbled by the year of the part March confision. fembled by the 15th of the next Month, confifting of twenty five thousand Danes, ten thousand Saxon Horse, and six Battalions, six thousand Muscovites, and sifteen thousand Poles. As the forming of this Army has been some time in Agitation, a Courier is daily expected here with the Measures concerted for the Junction of the respective Troops of which it is to be composed; and it appears that every thing relating to it will be managed with the greatest Expedition. The King's Field Equipage is already sent away, and it is thought his Majesty himself will set out in a few Days for Rensboarg in the Danish Holsein, whither all the General Officers, that are not there already, are ordered to repair immediately. The Baron de Lowendal went from hence some time since to Jutland, where he was to embark for Norway, and take with him a thousand Horse, and three Battalions of the Militia, to reinforce the Army in that Kingdom. Three Men of War and some Frigats having been appointed to transport those Forces, sail'd the 15th out of our Road under the Command of Admiral Seefladt, in order to receive 'em on Board at Flastrandt; and the Wind having continued fair ever fince, it is not doubted but that they are all arrived safe in Norway. The rest of the Fleet are ready to sail upon the first Orders from his Majesty.

Hanover, June 23. N. S. They write from Breslaw, that the Partisan Smiegielsky having continued his Incursions for some time with good Success, several Palatines and some of the Nobility that have been reduced to Want through the Calamities of the War, were thereby encouraged to join them-felves with him, by which means his Strength grew more formidable, and he and his Troops lived at Discretion, committing several Disorders on the Frontiers. Hereupon the Saxon and Muscovite Forces quarter'd in the Lower Poland were order'd to Pillage and Destroy the Houses and Effects of fuch as were known to be of his Party, and feveral Poles that were saspected to have maintain'd a Correspondence with him were immediately confined. At the same time the Great General sent out some Parties after him, of which he being sea-sonably advertis'd, he instantly retired with one hundred and sifty Horses and a great Booty towards Pomerania, and it is thought he is so far advanc'd that they will not be able to overtake him. These Letters add, that, according to their Advices from Belgrade and Temeswar, all the Cosfacks have declared for the Muscovites, and most of the Tartars are return'd to their own Habitations much diffatisfied with their late Expedition. The Electoral Princess has of late been somewhat indisposed, but boing near her Time, it is hoped has approaching Palinage which is a late. her approaching Delivery, which is daily expected, will soon restore her to her former State of Health.

The Prince of Savoy having received Advice that Marshal Villars had made a second Detachment for Germany on the 28th past, Orders have been sent hither for the Imperial Troops which remain here and at Louvain to rial I roops which remain nere and at Louvain to pursue their March towards the Army on the Rhine to Morrow; and according to the Dispositions that have been made, they will pass that River the 16th Instant at Bonn: And they write from the Hague, that the Prince himself will set cut from thence on the 9th for Germany.
