The Trunk Road (Betws-y-Coed, Gwynedd) (Prohibition of Waiting) Order 1981

Notice is hereby given that the Secretary of State for Wales proposes to make an Order under sections 1 (1), (2), (3) and 84D (1) of the Road Traffic Regulation Act 1967, as amended, the purpose of the proposed Order will be:

- to revoke and re-enact the provision of the Trunk Road (Betws-y-Coed) (Prohibition of Waiting) Order 1958;
- to prohibit the waiting of any vehicle at any time during the period 1st May to 30th September, both dates inclusive in any year, on any of the sides of road specified in Schedule 2 to this notice;
- to prohibit the waiting of any vehicle on any of the sides of road specified in Schedule 1 to this notice.

Exceptions in the proposed Order will permit waiting for the following purposes:

- picking up or setting down passengers;
- loading or unloading goods;

(c) building, industrial or demolition purposes;

(d) carrying out essential services connected with the maintenance of the road and the supply of gas, water and electricity.

The usual exceptions have also been provided in the Order for vehicles displaying a disabled person's badge.

A copy of the proposed Order, copies of the Order it is proposed to revoke and re-enact together with a plan and statement of reasons for making the Order may be seen during normal office hours at the offices of the Aberconwy Borough Council, Bodlondeb, Conwy.
