#### HIGHWAYS ACT 1980

*The Northamptonshire County Council (Gladstone Road to Mill Lane Railway Bridge, Northampton Classified Road) (Side Roads) Order 1980.*

### WIGAN METROPOLITAN BOROUGH COUNCIL

#### CLEAN AIR ACTS 1956/1968

##### *Wigan Borough Council (Leigh No. 16) Proposed Smoke Control Order 1981*

1. Notice is hereby given that the Wigan Borough Council in exercise of the powers conferred on them by section 11 of the Clean Air Act 1956, have, on 24th June 1981, declared their intention to make an Order entitled the Borough of Wigan (Leigh No. 16) Smoke Control Order 1981 declaring the area described in the Schedule hereto to be a Smoke Control Area.

2. Subject to the limitations and exemptions provided by the Order and by virtue of section 11 (4) of the Act, if, on any day after the Order has come into operation, smoke is emitted from any chimney of any building, the occupier of that building shall be guilty of an offence and liable to a fine not exceeding £100, unless he proves that the emission of smoke was not caused by the use of fuel other than an authorised fuel. The authorised fuels include anthracite, coke and other carbonised fuels, gas and electricity.

3. Copies of the Order and map referred to therein may be inspected, free of charge, at the District Office, Leigh, at all reasonable times during the period of 6 weeks from 8th July 1981.

4. Within the period specified in paragraph (3) above, any person who will be affected by the Order may by notice in writing to the Director of Administration, Civic Centre, Millgate, Wigan WN1 1YD, object to the making of the Order.

5. If the Council make the Order it will come into effect on 1st September 1982.

*Union Road*, on north-west side, from 25 feet south-west to 25 feet north-east of Church Road.

(b) To revoke the No Waiting at Any Time restriction in the following lengths of road:

*St. Mary's Road*, on south-east side, from 140 feet north-east to 240 feet north-east of Victoria Road.

*Victoria Road*, on north-east side, from 45 feet south-east of Granville Road to 45 feet north-west of St. Mary's Road.

(c) To revoke the No Waiting 9 a.m. to 7 p.m. restriction in the following length of road:

*Victoria Road*, on north-east side, from 250 feet south-east of St. Mary's Road to 100 feet north-west of Mill Hill Road.

The Order is designed to reduce congestion and delay in the said roads and to facilitate the traffic flow generally in the promotion of road safety and contains exemption clauses to permit loading and unloading of goods where appropriate, and came into operation on Monday, 29th June 1981.
