The County of Cornwall (Stratton) (One-Way Traffic) (Prohibition of Waiting) Order 1981

The County of Cornwall (Stratton) (One-Way Traffic) Order 1981

Notice is hereby given that the Council propose to make the above Orders to:

- (i) Prohibit the waiting of vehicles at any time in the lengths of road at Stratton specified in the First Schedule.

The Order will contain exceptions in favour of disabled persons vehicles in accordance with the Orange Badge Scheme and to allow boarding and alighting; loading and unloading; delivery and collection of postal packets; statutory powers or duties; building operations; works on roads and services; the taking in of petrol etc. from a garage; and funerals.

- (ii) Impose one-way traffic as specified in the length of road at Stratton set out in the Second Schedule.
(iii) Amend existing traffic regulation Orders as necessary to give effect to the foregoing.

Draft Orders and existing Orders, relevant maps and statements of reasons, may be inspected from 9.30 a.m. to 12.30 p.m. and 2.30 p.m. to 4 p.m. Mondays to Fridays inclusive, at my office and the North Cornwall District Council Offices at (i) Priory House, Bodmin, and (ii) The Castle, Bude.

Objections, specifying the grounds on which they are made, must be sent in writing to me by 24th August 1981.

FIRST SCHEDULE

Prohibition of Waiting

1. *Hospital Road (A3072)*, from its junction with Union Hill for a distance of 109 yards in a north-westerly direction.
2. *Bridge Street (A3072)*, between its junctions with Hospital Road and Howell's Road/Fore Street.
3. *Howell's Road (A3072)*
 - (i) both sides, from its junction with Bridge Street for a distance of 15 yards in a south-easterly direction;
 - (ii) north-eastern side, from a point 15 yards south-east of its junction with Bridge Street to its junction with Spicers Lane; and
 - (iii) south-western side, between points 47 yards and 120 yards south-east of its junction with Bridge Street.
4. *Old Post Office Hill (Unclassified)*
 - (i) western side, between its junctions with Howell's Road and Fore Street; and
 - (ii) eastern side, from its junction with Howell's Road for a distance of 16 yards in a north-easterly direction.
5. *Fore Street (Class III)*, between its junctions with Howell's Road/Bridge Street and Maiden Street.
6. *Maiden Street (Class III)*, from its junction with Fore Street for a distance of 38 yards in a northerly direction.
7. *Church Street (part Class III and part Unclassified)*
 - (i) northern side, between its junctions with Fore Street/Maiden Street and Cot Hill, including the western side of the carriageway to the north-west of the island site containing the war memorial; and
 - (ii) southern side, from its junction with Fore Street/Maiden Street for a distance of 37 yards in an easterly direction.

The County of Devon (Paul Street/Guildhall Multi-Storey Car Park Exeter) (Prohibition of Right Hand Turn) (Experimental) Order 1981.

Notice is hereby given that the Devon County Council propose to make an Order under sections 9 (1) and 84C (1) of the Road Traffic Regulation Act 1967, as amended.

The effect of the proposed Order will be to prohibit any vehicle making a right-hand turn from Paul Street into the Multi-Storey Car Park, Exeter, at such times as the requisite sign is displayed, and will be for an experimental period not exceeding 18 months during which time the situation will be reviewed.

A copy of the proposed Order, a map showing the affected road and a statement of the Council's reasons for proposing to make the Order may be inspected during usual office hours Monday to Friday at the office of the Area Engineer (East), Top Floor, Broadwalk House, Southernhay West, Exeter.

DEVON COUNTY COUNCIL

The Devon County Council (Lime Grove, Bideford) (Prohibition of Waiting) Order 1981

Notice is hereby given that the Devon County Council propose to make an Order under section 1 of the Road Traffic Regulation Act 1967, as amended, the effect of which will be to prohibit any vehicle from waiting on either side of Lime Grove from its junction with Northam Road and Pitt Lane, westwards for a distance of 14 metres (15 yards).

There will be exceptions in the proposed Order to permit vehicles to wait for the purposes of picking up and setting down of passengers, loading and unloading of goods and where necessary in connection with the maintenance of the road and the supply of gas, water and electricity. An exception relating to disabled persons' vehicles will also be included.

Full details of the proposals are contained in the draft Order which together with a map showing the length of road concerned and a statement of the Council's reasons for proposing to make the Order may be examined during normal office hours, Monday to Friday, at either Room 308, Civic Centre, Barnstaple, or Torrridge District Council, Town Hall, Bideford.

DEVON COUNTY COUNCIL

The County of Devon (Torcross Sea Front Road) (Prohibition of Driving) Order 1981

Notice is hereby given that on 24th July 1981, the Devon County Council made an Order under section 1 (1), (2) and (3) of the Road Traffic Regulation Act 1967, as amended.

When the Order comes into effect on 3rd August 1981 you will not be allowed to drive any motor vehicle in the following length of road:

Torcross Sea Front Road, from a point at its southern end adjacent to the eastern boundary of the Torcross Hotel northwards to a point 22 metres south of its northern junction with the A379.

Exemptions in the Order permit the driving of vehicles in the affected length of road for conveying persons or goods to or from adjacent premises, in connection with building operations, road repairs, etc., for emergency purposes or in the service of a local authority or statutory undertakers in pursuance of statutory powers or duties.

A copy of the Order together with a map showing the affected length of road may be examined during usual office hours, Monday to Friday, at the offices of South Hams District Council, Follaton House, Plymouth Road, Totnes or at the Town Hall, Kingsbridge, or at the address given below.
