NOTICE OF DISCLAIMER

*Notice of Disclaimer Under Section 355
of the Companies Act 1948*

Whereas:

(1) Pursuant to section 353 of the Companies Act 1948 Plumstead Car Hire Limited (hereinafter called "the Company") became dissolved on the 11th July 1980

THE LONDON-PENZANCE TRUNK ROAD (A30)
(HONITON, DEVON) (ONE-WAY TRAFFIC)
ORDER 1981

The Secretary of State for Transport hereby gives notice that he proposes to make an Order under section 1 (1), (2) and (3) of the Road Traffic Regulation Act 1967 as amended by Part IX of the Transport Act 1968 on the London-Penzance Trunk Road (A30) at Honiton in the District of East Devon in the County of Devon.

The effect of the Order will be to ensure that no person shall cause or permit any vehicle to enter or to proceed in that length of Exeter Road which forms the westbound access slip road
