CERTIFICATES OF TAX DEPOSIT (SERIES 5)

On and after 5th October 1981 until 12th October 1981, the rate of interest applicable to deposits accepted under the prospectus (series 5) dated 31st July 1980 and applied in payment of a scheduled liability was 16 per cent, and the rate of interest on deposits withdrawn for cash was 11½ per cent.
