The Trunk Road (Newport, Gwent) (Prohibition of U-turns) Order 1981

Notice is hereby given that the Secretary of State for Wales proposes to make an Order under sections 1 and 84D (1) of the Road Traffic Regulation Act 1967, as amended, the effect of which will be that no person shall, except upon the direction or with the permission of a police constable in uniform or of a traffic warden, cause or permit any vehicle proceeding in either of the carriageways of the length of road specified in the Schedule to this notice to make U-turns through the gaps in the central reservation of the said length of road so as to proceed in the opposite direction.

The proposed Order shall not apply to any vehicle travelling in the southbound carriageway making a U-turn through the gap in the central reservation at the junction of the trunk road with Hollybush Avenue.
