TOWN AND COUNTRY PLANNING ACT 1971

Newbury District Council (Bridleway 18 Thatcham) (Part) Public Path Diversion (No. 2) Order 1982

Notice is hereby given that the above-named Order made on 26th August 1982, is about to be submitted to the Secretary of State for the Environment for confirmation or to be confirmed as an unopposed Order by the Newbury District Council.

The effect of the Order, if confirmed without modification, will be to divert the part of the path commencing from a point approximately 120 metres south of the Distributor Road and running in a south-south-westerly direction for a distance of approximately 229 metres, to a line commencing from the same starting point and running in an east-south-easterly direction for a distance of approximately 62 metres, a south-south-westerly direction for a distance of approximately 31 metres a south-south-easterly direction for a distance of approximately 124 metres, then in a south-south-westerly direction for a distance of approximately 58 metres then continuing in a generally westerly direction for a distance of approximately 55 metres before rejoining the original path.

A copy of the Order and the map contained therein has been deposited and may be inspected free of charge at the Newbury District Council, Council Offices, Market Street, Newbury, during normal office hours.

Any representation or objection with respect to the Order may be sent in writing to the Director of Legal and Administrative Services, Newbury District Council, Market Street, Newbury before 1st October 1982 and should state the grounds on which it is made.

If no representations or objections are duly made, or if any so made are withdrawn, the Newbury District Council may, instead of submitting the Order to the Secretary of State for the Environment, itself confirm the Order. If the Order is submitted to the Secretary of State for the Environment any representations and objections which have been duly made and not withdrawn will be transmitted with the Order.
