The Trunk Road (A40) (Lay-Bys East of Haverfordwest) (Prohibition of Traffic) Order 1983

Notice is hereby given that the Secretary of State for Wales proposes to make an Order under section 1 of the Road Traffic Regulation Act 1967, as amended. The effect of the proposed Order will be to prohibit (with certain exceptions) any vehicle proceeding in or into the lay-bys on the London—Fishguard Trunk Road (A40) (hereinafter referred to as "the trunk road"), specified in Schedules 1 and 2 to this notice.
