UNIVERSITIES OF OXFORD AND CAMBRIDGE ACT 1923

A Statute made by the Governing Body of St. John's College, in the University of Cambridge, on 17th November 1983 has been submitted for the approval of Her Majesty in Council, and notice of its having been so submitted is published in accordance with the provisions of the Universities of Oxford and Cambridge Act 1923.

The Trunk Road (A5) (Britannia Bridge, Gwynedd) (Clearway) Order 1983

Notice is hereby given that the Secretary of State for Wales has made an Order under sections 112 (1), (12) and 84D of the Road Traffic Regulation Act 1967, as amended, which shall come into operation on 19th December 1983.

The effect of the Order is to prohibit (with certain exceptions) the waiting of vehicles in the carriageway of that length of trunk road specified in the Schedule to this

The Order will also prohibit trading from the verges and lay-bys of that length of the trunk road.

A copy of the Order, a copy of the Order to be revoked together with a plan and statement of reasons for making the Order, may be seen during normal office hours at the offices of the Isle of Anglesey Borough Council, Borough Council Office, Llangefni, Anglesey LL77 7TW, and Arfon Borough Council, Town Hall, Bangor, during a period of 6 weeks from 21st November 1983.

If you wish to question the validity of the Order or of any provision contained therein on the grounds that it is not within the powers conferred by the Road Traffic Regutogether with a plan and statement of reasons for making

lation Act 1967, as amended by Part IX of the Transport Act 1968, or that any requirement of that Act or of any instrument made under it, has not been complied with in relation to the Order, you may, within 6 weeks of 21st November 1983 apply to the High Court for the suspension or quashing of the Order or of any provision contained therein.

SCHEDULE

That length of the London—Holyhead Trunk Road (A5) at Llanfairpwllgwngyll in the county of Gwynedd, which extends from the junction of the trunk road with the entry and exit slip roads connecting the main carriageway of the trunk road with the Llanfairpwll Menai Bridge Trunk Road (A5/A4080), in a north-westerly direction to a point 1470 metres west of the centre point of the bridge carrying the Llanfairpwll—Amlwch Valley County Road (A5025) over the trunk road.
