

## CHELMSFORD BOROUGH COUNCIL

*The Borough of Chelmsford (Rainsford Road and Park Avenue, Chelmsford) (Prohibition of Waiting) Order 1984.*

Notice is hereby given that the Chelmsford Borough Council, acting as agents of the Essex County Council, have made an Order under section 1 (i), (ii) and (iii) of the Road Traffic Regulation Act 1967, as amended.

The effect of the Order is to prohibit the waiting of vehicles between the hours of 8 a.m. and 9.30 a.m. and 4.30 p.m. and 6 p.m., Mondays to Saturdays, in the following lengths of road:

*Rainsford Road*, southern side, from the existing restrictions 25 metres west of its junction with Rainsford Avenue in a westerly direction to a point 7 metres east of its junction with Park Avenue.

*Park Avenue*, both sides, from its junction with Rainsford Road in a northerly direction for a distance of 31 metres.

A copy of the Order, together with a map showing the roads affected are available in Room 27, Secretarial Department, Civic Centre, Chelmsford, where they may be inspected during normal office hours.

If you wish to question the validity of the Order or of any provision contained in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1967, as amended, or on the grounds that any requirement of that Act or of any Instrument made under it, has not been complied with in relation to the Order, you may, within 6 weeks from 23rd February 1984, being the date the Order was made, apply to the High Court for this purpose.

*The Borough of Chelmsford (Service Road off Rainsford Road, Chelmsford) (Prohibition and Restriction of Waiting) Order 1984.*

Notice is hereby given that the Chelmsford Borough Council, acting as agents of the Essex County Council, have made an Order under section 1 (i), (ii) and (iii) of the Road Traffic Regulation Act 1967, as amended.

The effect of the Order will be to impose the following restrictions:

*No Waiting at Any Time*

*Service Road off Rainsford Road:*

East side, from its junction with Rainsford Road for a distance of 62 metres, including the turning area.

West side, from its junction with Rainsford Road for a distance of 20 metres.

West side, from a point 45 metres from its junction with Rainsford Road for a distance of 17 metres.

*Limited Waiting Mondays to Saturdays 8 a.m. to 6 p.m.*

*Maximum of 1 hour in any 1 hour*

*Service Road off Rainsford Road*, west side, from a point 20 metres from its junction with Rainsford Road southerly for a distance of 25 metres.

The effect of the Order will be to impose the following restrictions:

*No Waiting at Any Time*

*St. John's Green*, Writtle, both sides, from its junction with Bridge Street in a northerly direction for a distance of 16 metres.

*Bridge Street*, Writtle, both sides, from a point 15 metres west of a point in the centre of its junction with St. John's Green, for a distance of 51 metres in an easterly direction.

*Lodge Road*, Writtle, both sides, from its junction with Bridge Street in a southerly direction for 32 metres.

*No Waiting Mondays to Saturdays 8 a.m. to 6 p.m.*

*St. John's Green*, Writtle, eastern side, from a point at the terminal of the restrictions 16 metres north of its junction with Bridge Street, in a northerly direction for a distance of 90 metres.

*Lawford Lane*, Writtle, southern side, from its junction with St. John's Road in an easterly direction for a distance of 18 metres.

Notice is hereby given that the Chelmsford Borough Council, acting as agents of the Essex County Council, have made an Order under section 1(i), (ii), and (iii) of the Road Traffic Regulation Act 1967, as amended.

The effect of the Order will be to impose the following restrictions:

*No Waiting at Any Time*

*Maltese Road*

Both sides, from a point 100 metres north of its junction with Rainsford Road in a northerly direction for a distance of 62 metres.

Both sides, from a point 414 metres north of its junction with Rainsford Road in an easterly direction around the turning head at the end of Maltese Road.

*Valetta Close*, both sides, from its junction with Maltese Road in an easterly direction for a distance of 15 metres.

*No Waiting Mondays to Saturdays 8 a.m. to 6 p.m.*

*Maltese Road*

Eastern side, from a point 15 metres north of its junction with Rainsford Road in a northerly direction for a distance of 24 metres.

Eastern side, from a point 162 metres north of its junction with Rainsford Road in a north then easterly direction for a distance of 252 metres.

Western side, from a point 15 metres north of its junction with Rainsford Road in a northerly direction for a distance of 85 metres.
