CERTIFICATES OF TAX DEPOSITS (SERIES 6)

On and after 11th April 1984, the rates of interest applicable to deposits accepted under the Prospectus (Series 6) dated 11th October 1982 will be as follows:

(a) for deposits of £100,000 or over:

For deposits made under earlier Prospectuses (Series 4 and 5) which reach the second or fourth anniversary of the deposits, as applicable, in accordance with the terms and conditions set out therein: 9½ per cent if the deposit is applied in payment of a scheduled liability, and 7 per cent if the deposit is withdrawn for cash.
