Notice is hereby given that pursuant to arrangements made under section 101 of the Local Government Act 1972 with the Bedfordshire County Council, Luton Borough Council propose to make the above-named Orders under sections 1 and 2 of the Road Traffic Regulation Act 1984.

The effect of the Orders will be to introduce the follow-

ing traffic management measures:

No waiting 8 a.m. to 6 p.m. Monday to Saturday

Blundell Road, north-west side, from the north-east boundary of No. 2 Marsh Road to the north-east boundary of No. 33 Blundell Road.

Frederick Street, both sides, from its junction with Old Bedford Road to the boundary between Nos. 21 and 23 Frederick Street.

Hibbert Street, north-east side, from its junction with Castle Street to the boundary between Nos. 39 and 41 Hibbert Street.

Riddy Lane, north side, from a point opposite its eastern junction with Rosslyn Crescent for a distance of 24 metres in a westerly direction.

No waiting at any time

Ashton Road, both sides, from its junction with Hibbert Street to a point 15 metres south of the south kerb-line of Hibbert Street (existing restrictions: no waiting 8 a.m. to 6 p.m. Monday to Saturday).

Windsor Walk, both sides, from its junction with Dum-fries Street to its junction with Windsor Street and from its junction with Windsor Street to its junction with Russell Street.

No waiting at any time (except Sundays)

Chapel Street, north-west side, from its junction with George Street to the north-eastern boundary of No. 12 Chapel Street (existing restriction includes Sundays).

No waiting 9 a.m. to 5 p.m. Monday to Friday

Faringdon Road, east side, from its junction with Lime Avenue to its junction with Calnwood Road (existing restriction; no waiting 9 a.m. to 4 p.m. Monday to Friday).

Revocation of waiting restrictions

Ashton Road, south-east side, from a point between the boundaries of Nos. 93 and 95 Ashton Road to a point between the boundaries of Nos. 123 and 125 Ashton

No waiting 8 a.m. to 6 p.m. Monday to Friday

Hillborough Road, north side, from its junction with Russell Rise to the entrance to the Hillborough Schools.

The draft Orders contain exemptions in the standard Ine draft Orders contain exemptions in the standard form, permitting waiting for the purpose of boarding or alighting and loading or unloading goods and where necessary, in connection with building operations, road and sewer works and public utilities street works. Disabled persons' vehicles bearing the prescribed disabled person's badge and parking disc will be permitted to wait for a period not exceeding 2 hours. not exceeding 2 hours.

The Borough of Macclesfield (Riseley Street and Walker Street, Macclesfield) (Prohibition and Restriction of Waiting) Order.

The Borough of Macclesfield (Off Street Parking Places, Macclesfield) (Amendment No. 4) Order

The Borough of Macclesfield (Civic Hall Off Street Car Park Poynton) (Weight Restriction) Order

Notice is hereby given that the Macclesfield Borough Council acting pursuant to arrangements made with Cheshire County Council in accordance with section 101 of the Local Government Act 1972 or with the consent of Cheshire County Council propose to make the above Orders in accordance with the Road Traffic Regulation Act 1984.

The effect of the Orders will be as follows:

1. Borough of Macclesfield (Park Lane (Part) (Macclesfield) (Prohibition of Waiting) Order.

To prohibit waiting at any time on the north side of Park Lane, Macclesfield from a point 46 metres south-west of its junction with Brown Street for a distance of 25 metres in a south-westerly direction.

2. Borough of Macclesfield (Pool Street, Waller Street, Mill Lane and River Street, Macclesfield) (Prohibition of Waiting) Order.

(1) To prohibit waiting at any time:

(i) Pool Street

West side, from its junction with Windmill Street for a distance of 15 metres in a southerly direction, and from its junction with River Street for a distance of 15 metres in a northerly direction.

East side, from its junction with Windmill Street for a distance of 25 metres in a southerly direction.

River Street north side from its junction with Mill

(ii) River Street, north side, from its junction with Mill Lane to its junction with Pool Street.

(iii) Mill Lane, east side, from its junction with River Street for a distance of 17 metres in a northerly direction.

(2) To prohibit waiting 8 a.m. to 6 p.m., Monday to Saturday inclusive on:

(i) Pool Street, west side, from a point 15 metres south of its junction with Windmill Street to a point 15 metres north of its junction with River Street.

(ii) Waller Street, north side, from its junction with Mill

Lane to its junction with Pool Street.

(iii) River Street, south side, from its junction with Mill Lane for a distance of 20 metres in an easterly direction.

3. Borough of Macclesfield (Cottage Street (Part) and Oxford Road (Part) Macclesfield) (Prohibition of Waiting)

To prohibit waiting at any time on:

Oxford Road

East side, from its junctions with Chester Road to its junction with Beswick Street.

West side, from its junction with Chester Road to its

junction with Frances Street.

Cottage Street, both sides, from its junction with Oxford Road to the east side of its junction with Hand

Borough of Macclesfield (Risley Street and Walker Street, Macclesfield) (Prohibition of Waiting) Order.
 To prohibit and restrict waiting as follows:

(1) Riseley Street; Macclesfield

(i) No waiting at any time

North-east side, from its junction with Grosvenor Street for its entire length in a north-westerly direction, including the end.

South-west side:

from its junction with Grosvenor Street for a distance of 21 metres in a north-westerly direction; from its junction with Walker Street for a distance of 5 metres in a south-easterly direction; from its junction with Walker Street for a distance

of 45 metres in a north-westerly direction.
