*The District of Selby (Off-street Parking Places) (Tadcaster) Order 1986*

Notice is hereby given that on 7th May 1986 the Selby District Council made the above Order under section 35 (1) and 46 of the Road Traffic Regulation Act 1984 which is to control the use of and to introduce charging for the use of the Britannia and Central Area Car Parks, Tadcaster. The class of vehicles, the days and times of operation and the scale of charges proposed for the parking places are shown in the Schedule to this notice.

The Order, which together with a map showing the location of the parking places, may be seen at:

- (a) The Civic Centre, Portholme Road, Selby, between the hours of 8.30 a.m. and 5 p.m., Monday to Thursday and 4.30 p.m. on Fridays;
- (b) 43 Kirkgate, Tadcaster, between the hours of 9 a.m. and 4.30 p.m., Monday to Wednesday, and 9 a.m. and 4 p.m. on Fridays

and is effective from 2nd June 1986.
