ROAD TRAFFIC REGULATION ACT 1984

(Walkergate, Berwick-upon-Tweed) (Waiting Restriction) (Revocation) Order 1987

Notice is hereby given that Northumberland County Council have made an Order under sections 1(1) and (2) and paragraph 20 of Schedule 9 of the Road Traffic Regulation Act 1984, to come into operation on 23rd March 1987 which will have the following effect:

Revoke the waiting restriction on the north-western side of Walkergate, Berwick-upon-Tweed from a point 6 metres west of the western channel line of Hatters Lane in a south-westerly direction for a distance of 31 metres, as imposed by item 3 of the fourth Schedule of "The county of Northumberland (Berwick-upon-Tweed) (Traffic Regulation) Order (No. 2) 1973".

HERTFORDSHIRE COUNTY COUNCIL

The Hertfordshire (Various Roads, Codicote) (Weight Restriction) Order 1986

Notice is hereby given that the Hertfordshire County Council have made an Order under sections 1(1) and 2, 2(4) and 3(2) of the Road Traffic Regulation Act 1984, the effect of which will be to prohibit heavy commercial vehicles as defined in section 138 (1A) of the said Act of 1984, from proceeding along the lengths of roads specified in the Schedule to this notice.

Usual exemptions will apply to allow loading and unloading of vehicles at premises on or adjacent to the lengths of roads specified, to allow for agricultural uses on land adjacent to the roads, to allow for building works, highway and public utility works on the length of roads, to allow for public service vehicles or emergency service vehicles, and to allow for vehicles to proceed to premises where they are being garaged, serviced or repaired.

A copy of the Order which comes into operation on 23rd March 1987 and a plan showing the roads to which the Order relates, may be inspected at the offices of the North Hertfordshire District Council, Council Offices, Gernon Road, Letchworth, and at Room 204 County Hall, Hertford.

Any person wishing to question the validity of the Order, or of any provision contained in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984, or on the grounds that any requirement of the Act, or of any

instrument made under it, has not been complied with in relation to the Order, may within 6 weeks from the date of this notice, apply to the High Court for this purpose.

CLWYD COUNTY COUNCIL

The County Council of Clwyd (Record Street, Ruthin) (Prohibition of Waiting) Order 1987
