EAST SUSSEX COUNTY COUNCIL

The East Sussex (Regency Close, Uckfield) (Prohibition of Waiting Order 1987

Notice is hereby given that with reference to Public Notice number 721 which appeared in issue number 50846 of the *London Gazette* on 27th February 1987, East Sussex County Council has made an Order under sections 1(1) and (2), 2(1) to (3) and 4(2) of the Road Traffic Regulation Act 1984 which prohibits waiting at any time along parts of Regency Close, Uckfield, to prevent obstruction by parked vehicles.

This Order is considered necessary to facilitate the passage and turning manoeuvres of vehicles in Regency Close and its junction with Church Street.

Exceptions are included in the Order in respect of disabled persons' vehicles and to permit picking up and setting down passengers, loading and unloading goods, roadworks and the maintenance of essential services.

The Waltham Forest (Auckland Road, London E.10) (Prescribed Route) (No.) Traffic Order 198

Notice is hereby given, that the Council of the London Borough of Waltham Forest propose to make the above-mentioned Order under section 6 of the Road Traffic Regulation Act 1984, as amended by the Local Government Act 1985.

The general effect of the Order would be to prohibit vehicles from entering that length of the carriageway of Auckland Road, London E.10, which lies between the south-eastern kerbline of Buckingham Road and a point 4 metres south-east of that kerbline. (A barrier would be erected in this length of carriageway.)

The prohibition referred to above would not apply:
