THE STOPPING UP OF HIGHWAYS (DERLWYN, GLYNNEATH) ORDER 1987

SCHEDULE (all distances are approximate)

The highway to be stopped up is at Derlwyn, Glynneath, in the county of West Glamorgan, and is that length of unclassified road known as "Old Parish Road" which extends from a point 421 metres north-west of the derelict "Bryn-Ceffylau" Farmstead to a point 785 metres north-east of the said "Bryn-Ceffylau" Farmstead; a total distance of 987 metres.

or quashing of the Order or of any provision contained therein.
