HARBOURS ACT 1964

*The Proposed Shoreham Port Authority Revision Order*

Notice is hereby given that a Public Local Inquiry in connection with the above proposed Order will be held by Mr G. J. Bryan (a person appointed by the Secretary of State for that purpose) at the Harbour Office, Albion Street, Southwick, Brighton, West Sussex BN4 4ED on 12th January 1988 at 10 a.m. when representations from persons who have objected to the draft Order, and from any other persons who desire to appear, will be heard.

The proposed Order, which has been applied for by the Shoreham Port Authority under section 14 of the above Act:

- (1) Empowers the Authority to provide, maintain, operate and improve port facilities in, or in the vicinity or, the port of Shoreham and to take such action as they consider necessary or desirable for or incidental to the maintenance, operation, improvement and conservancy of the port;
- (2) Empowers the Authority, either by themselves or by arrangement with others, to take action for:
  - (a) the discharge, or for facilitating the discharge, of their duties, including the proper development or operation of the port undertaking;
  - (b) the provision, maintenance and operation of certain services and facilities;
  - (c) turning their resources to account;
- (3) Authorises the Authority to acquire and dispose of certain businesses and undertakings and to invest in and form companies;
- (4) Empowers the Authority to acquire land by agreement and to retain or dispose of it or to manage, use or develop it and to repeal it and to repeal earlier enactments relating thereto.
