The purpose of this Statute is to amend provisions relating to: the residential requirement necessary for names to be inscribed on the Roll of Regent House; election to the Council of the Senate; admission of women students; voting at meetings of University bodies; age limit for membership of Boards; vacancies in professorships; duties of the Orator; and examination regulations.

HIGHWAYS ACT 1980

The Trunk Road A1081 (Bell Roundabout-London Colney Roundabout, Hertfordshire) (Detrunking) Order 198

The Secretary of State for Transport hereby gives notice that he proposes to make an Order under sections 10 and 12 of the Highways Act 1980, the effect of which will be that the A1081 trunk road between its junction with the M25 (Bell Roundabout) and its junction with the A414 (London Colney Roundabout) shall cease to be a trunk road and shall be classified as principal road as from the date on which the Order comes into force.
