## ROAD TRAFFIC REGULATION ACT 1984

*Borough Council of Gateshead (Felling By Pass (A6115)

Establishment of Pedestrian Crossings*

Notice is hereby given that the Borough Council of Gateshead propose to make Orders under sections 1, 84 and part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act").

The effect of the proposed Orders will be:

- (a) subject to the Secretary of State for Transport's consent to extend the existing 40 m.p.h. Speed Limit on the Felling By Pass (A6115) a further 140 metres eastwards thereby making the length of road between Park Lane Roundabout and Stoneygate Lane Bridge subject to that limit and it is proposed that the existing restrictions and the proposed be consolidated into one Order;
- (b) To impose a 40 m.p.h. Speed Limit on the Felling By Pass/Stoneygate Lane Slip Road and
- (c) to introduce a One-Way Westbound movement on the slip road.

The Council on 30th October 1987 in exercise of their powers under section 23(1) of the Act, and after consultation with the Chief Officer of Police also approved the siting of Pelican Crossings on Felling By Pass (A6115) adjacent to Orchid Crescent and Green Lane. It is proposed that the works to install the crossings will be carried out during June/July 1988.

Full details of the proposals copies of the draft Orders together with plans and a statement of the Council's reasons for proposing to make the Orders may be examined at the offices of the Director of Legal Services, Civic Centre, Regent Street, Gateshead, during normal office hours.

*(Jackson Street, Gateshead) Traffic Regulation Order 1988*

Notice is hereby given that on 15th April 1988 the Borough Council of Gateshead made an Order under section 1 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984.

The effect of the Order which comes into operation on 24th April, 1988 is to revoke and re-enact with amendments the traffic restrictions applicable to Jackson Street, Gateshead. The main amendments would be:

- (1) The removal of the existing:
  - (a) prohibition of driving of motor vehicles except for access and buses;
  - (b) loading/unloading restrictions (8 a.m. to 9.15 a.m. and 4 p.m. to 6 p.m.) on a 50 metre length of the north side, and
- (2) The introduction of:
  - (a) a one-way westbound restriction except for buses using the proposed contraflow bus lane;
  - (b) a loading/unloading restriction at any time on the north side of Jackson Street extending from its junction with West Street eastwards for 50 metres.

A copy of the Order which together with a map and a statement of the Council's reasons for making the Order may be examined at the offices of the Director of Legal Services, Civic Centre, Regent Street, Gateshead, Monday to Thursday 8.45 a.m. to 5 p.m. and Friday 8.45 a.m. to 4.30 p.m.

If you wish to question the validity of the Order or of any provisions contained therein on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984 or on the grounds that any requirement of that Act or of any

instrument made under it has not been complied with in relation to the Order you may within 6 weeks from 15th April, 1988 apply to the High Court for this purpose.
