MERTON BOROUGH COUNCIL

London Borough of Merton (Waiting and Loading Restrictions) (No. 51) Traffic Order 1988, Durnsford Road, Wimbledon

Notice is hereby given that the Council of the London Borough of Merton, after consulting the Commissioner of Police of Metropolis in exercise of power conferred by sections 6 and 124 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 have made the above-mentioned Order on 27th July 1988. The Order will come into operation on 8th August 1988.

The general effects of the Order will be to further amend the Merton (Waiting and Loading Restrictions) Order 1977, so that no person shall cause or permit any vehicle to wait in that length of Durnsford Road between a point 18-29 metres north-west of the north-western kerb-line of Arthur Road and a point opposite the southern flank wall of No. 246 Durnsford Road between the hours of 8 a.m. and 6.30 p.m. Mondays to Saturdays inclusive. As a consequence, the same restrictions will apply 18-29 metres long Gresham Way from its junction with Durnsford Road.

Exemptions are provided in the Order to permit vehicles to wait:

- (a) to enable passengers to board or alight and to load or unload their personal luggage;
- (b) for up to 20 minutes for the purpose of delivering/collecting goods or loading/unloading the vehicle at premises adjacent to the street between the hours of 11 a.m. and 6.30 p.m. on Mondays to Saturdays inclusive;
- (c) if they are being used to maintain the road or the services therein or by Local Authorities or the Post Office in pursuance to statutory powers and duties.

SOUTHWARK LONDON BOROUGH COUNCIL

The London Borough of Southwark (Prescribed Routes) (No. 6) Traffic Order 1988

The London Borough of Southwark (Waiting and Loading Restriction) (Amendment No. 59) Traffic Order 1988

Notice is hereby given that the Council of the London Borough of Southwark on 2nd August 1988 made the above-mentioned Orders under sections 6 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended by Schedule V Part 1 Paragraph 4 (3) (a) of the Local Government Act 1985.

The general effect of the Prescribed Routes Order will be, in connection with the creation of a cycle route from St. George's Road to Southwark Bridge Road via Princess Street, Ontario Street and Keyworth Street to by-pass Elephant and Castle to:

- (a) prohibit all vehicles except pedal cycles from entering or proceeding or waiting in the cycle lane (which will be indicated by carriageway markings and surfaced with red asphalt) created:
- (i) on the south-western side of St. George's Road between Princess Street and Elliots Row:

(ii) in Southwark Bridge Road (A) between Gaunt Street and Newington Causeway and (B) between the southern extremities of the island sites situated at the junction of Gaunt Street and Southwark Bridge Road and a point 32 metres north of the northern extremity of the westermost of those island sites:

(b) revoke the one-way working for vehicles in that length of St. George's Road comprising the cycle lane referred to in sub-paragraph (a) (i) and imposed by item 7 of the London Traffic (Prescribed Routes) (Southwark) Regulations 1963;

(c) revoke and re-enact in a revised form the provisions of the Southwark (Prescribed Routes) (No. 7) Traffic Order 1966 so as to reverse the one-way working in that length of Southwark Bridge Road comprising the cycle lane referred to in subparagraph (a) (ii) (A) above so that it will operate in a north to south direction. The cycle lane referred to in sub-paragraph (a) (ii) (B) above will also operate in a north to south direction;

(d) prohibit vehicles (except pedal cycles) from entering Ontario Street between Keyworth Street and London Road. (A barrier will be erected in Ontario Street at a point 9 metres south of the

southern kerbline of Keyworth Street):

This prohibition will not apply in relation to the following vehicles entering Ontario Street from Keyworth Street:

(i) a vehicle being used for fire brigade, ambulance or police

purposes in an emergency;

(ii) any vehicle when used in the service of a local authority in pursuance of statutory powers or duties provided that in all the circumstances it is reasonably necessary in the exercise of such powers or in the performance of such duties for that vehicle to enter Ontario Street;

(e) prohibit vehicles in London Road from entering Princess Street:


