RATES OF INTEREST ON LOANS FROM THE NATIONAL LOANS FUND

NOTICE

The Treasury in pursuance of section 5 of the National Loans Act 1968 (as amended) hereby give notice that on or after 26th July 1989:

- (i) Different rates of interest shall apply according to whether the principal of a loan is repaid by instalments or at maturity and, if repaid by instalments, whether by equal instalments of the principal with interest paid on the decreasing balance of the principal (E.I.P.), or by instalments of equal repayments of the principal and interest paid thereon (E.R.);
- (ii) The lowest rates of interest satisfying the conditions laid down in section (3) of the said section 5 shall be:

The Secretary of State for Wales hereby gives notice that he proposes to make the following Order:

- (1) An Order under sections 10 and 12 of the Highways Act 1980 providing:
 - (a) that a road about 5.82 kilometres in length which he proposes to construct commencing at a point on the trunk road about 340 metres south-west of its junction with Upper Bryn Coch Lane, extending in an east then north-easterly direction to a point on the trunk road about 380 metres east of its junction with Bryn Lane at Mold, in the county of Clwyd, shall become a trunk road as from the date when the Order comes into force, and
 - (b) that the length of the Dolgellau-South of Birkenhead Trunk Road to be superseded, shall cease to be a trunk road as from the date on which notice is given by him to the County Council of Clwyd (who will become the highway authority for that length), that the said new trunk road is open for through traffic; and
 - (c) that The Dolgellau-South of Birkenhead Trunk Road (Mold By-pass) Order 1977 (S.I. 1977/1436) be revoked.
- (2) An Order under sections 12, 14, 125 and 326 of the Highways Act 1980, authorising him
 - (a) to carry out the improvement of highways

- (b) to stop up highways
- (c) to construct new permanent highways
- (d) to construct a temporary highway
- (e) to stop up private means of access to premises,
- (f) to provide new means of access to premises, and
- (g) to provide for the revocation of The Dolgellau-South of Birkenhead Trunk Road (Mold By-pass Side Roads) Order 1977.

all at Mold, aforesaid, and providing for the transfer of the said new highways to the County Council of Clwyd as from the dates on which he notifies the Council that the new highways have been completed and are open for through traffic.

Copies of the draft Orders and of the relevant plans, may be inspected free of charge at all reasonable hours, from 28th July 1989 to 8th September 1989, or within 6 weeks from the date of the publication of this notice, whichever period shall expire later, at the offices of Clwyd County Council, Shire Hall, Mold; Delyn Borough Council, Civic Offices, Holywell; Mold Library, Daniel Owen Centre, Earl Road, Mold, Mynydd Isa Community Centre, Mynydd Isa, Mold and at the Welsh Office, Highways Directorate, Roads Administration Division, Phase 1, Government Buildings, Ty Glas Road, Llanishen, Cardiff.

Any person may, not later than 8th September 1989, or within 6 weeks from the date of publication of this notice, if such period shall expire later, object to the making of either of the Orders by notice to the Welsh Office, Highways Directorate, Roads Administration Division, Phase 1, Government Buildings, Ty Glas Road, Llanishen, Cardiff, quoting ref. WR11/1/162, and stating the grounds of objection. In the preparation of an objection, and the statement of grounds of objection, it should be borne in mind that the substance of any objection or representation may be communicated to other people who may be affected by it.
