#### **TOWN AND COUNTRY PLANNING ACT 1971**

The Secretary of State for Transport hereby gives notice that he proposes to make an Order under section 209 of the above Act to authorise the stopping-up of an area of Back Lancefield Avenue, St. Anthony's Estate, Walker, Newcastle-upon-Tyne, to enable residential development consisting of the extension of private gardens, including erection of fencing, construction of paved areas and paths and landscaping, to be carried out in accordance with planning permission granted by Newcastle-upon-Tyne City Council under Part III of the said Act. The proposed Order will require the improvement of Back Lancefield Avenue by the provision of a footway.
