H.M. CUSTOMS AND EXCISE

NOTICE OF SEIZURE UNDER THE CUSTOMS AND EXCISE MANAGEMENT ACT 1979

C. Pooley Esq., 20 Brands Road, Colnbrook, Slough, Berkshire 4th April 1990

Pursuant to Section 139(6) of the Customs and Excise Management Act 1979, and paragraph 1 of Schedule 3 thereto, the Commissioners of Customs and Excise hereby give notice that by virtue of the powers contained in the Customs and Excise Acts, certain goods, namely a Peugeot 504 Motor Vehicle Registration No. UPM 929S of which you are the registered owner and which was detained by an officer of Customs and Excise from the car park of the Shell Service Station at Cumberland Avenue, Slough, Berkshire, on 15th July 1988 has been seized as liable to forfeiture by force of the following provisions:

1. Section 141(1)(a) of the Customs and Excise Management Act 1979: In that on a date or dates unknown on or before 15th July 1988, heavy oil on whose delivery for home use rebate had been allowed, was taken into the said motor vehicle being a road vehicle (as defined by Section 27 of Hydrocarbon Oil Duties Act 1979 ("the Act")) as fuel contrary to Section 12(2) of the Act such that the said oil has become liable to forfeiture pursuant to Section 13(6) of the Act and, further, the said vehicle has been used for the carriage and/or deposit of the said oil when the said oil was liable to forfeiture as aforesaid and/or for the purposes of the commission of the offence under Section 12(3) of the Act for which the said oil later became liable to forfeiture as aforesaid.

If you claim that the said goods are not liable to forfeiture you must within one month from the date of this notice of seizure give notice of your claim in writing in accordance with paragraphs 3 and 4 of Schedule 3 to the Customs and Excise Management Act 1979.

If you are outside the United Kingdom and the Isle of Man you must also give name and address of a solicitor in the United Kingdom who is authorised to accept service of process and act

on your behalf.

If you do not give notice of claim within the said period of one month or, if any requirement of the above-mentioned paragraph 4 is not complied with the goods in question will be deemed to have been duly condemned as forfeited.

If you do give notice of claim in proper form, the Commissioners will take legal proceedings for the condemnation of the said goods.

The Commissioners of Customs and Excise further give notice that a sample of hydrocarbon oil has been taken from the said motor vehicle and that one part of that sample is available for delivery to you, if you require it, from the Customs and Excise Office at Building 233, Nestles Avenue, Hayes, Middlesex UB3 4RJ between the hours of 9 a.m. and 4 p.m. on any week day.
